Ten Education Scholarships of \$4,000 each for Graduating High School Seniors in the Class of 2025

The Pennsylvania State Council, Knights of Columbus, is offering ten scholarships for members, sons and daughters of members, and qualified members of the Columbian Squires. Each scholarship entitles the awardee to receive up to \$4,000 over a six-year period to defray expenses for tuition, books, or maintenance in any college or school of nursing approved by the committee. Acceptance of one of these scholarships does not preclude the winner from enjoying any other scholarship the awardee may win unless other restrictions prevail.

CONDITIONS OF THE AWARD

Each candidate must be at least one of the following:

- a currently paid-up member of a Knights of Columbus council in the jurisdiction of Pennsylvania
- a child or stepchild of a currently paid-up member of a Pennsylvania Knights of Columbus council
- a child or stepchild of a deceased member of a Pennsylvania Knights of Columbus Council who was not in arrears at the time of his death
- a qualified Columbian Squire or Squire Rose

NOTE: Grandchildren are not eligible unless the grandparent is the legal guardian of the applicant

Other conditions that must be met:

- the candidate must be a practicing Catholic in communion with the Holy See
- the candidate must be a candidate for graduation from a recognized 4-year high school, or its home school equivalent, during the term ending in June 2025 (or January 2025 for early graduates)
- the application **must** be postmarked no later than **December 31, 2024** and mailed to the Scholarship Chairman of the Pennsylvania State Council, Knights of Columbus, using the attached form or an *exact* duplicate thereof. The application must include signatures of the applicant, parent or guardian, pastor, or associate pastor of the applicant, an official in the applicant's school verifying that the applicant is a candidate for graduation in 2025, the Grand Knight and Financial Secretary of the council to which the applicant or applicant's father belongs, or of the Chief Squire of the Columbian Squire Circle of which the applicant is a member.
- The council of the applicant must have completed and submitted Form 185 (Report of Officers Chosen for Term).
- The council of the applicant or applicant's father **must sell at least 75 Chance of a Lifetime (C.O.A.L.)** tickets as distributed by the Pennsylvania State Council, Knights of Columbus, for the 2024-25 campaign. For Columbian Squires, the circle's sponsoring council or assembly must sell at least 75 C.O.A.L. tickets by or before April 15, 2025. This claim **will** be checked against the COAL chairman's records.

Each scholarship winner must attend a college or a school of nursing affiliated with a hospital in order to receive payment. Such college or school may be under Catholic or non-Catholic auspices, subject to approval by the committee. Payments will be made to the school directly, not to the winner.

HOW TO PROCEED

(DETACH AND RETAIN - NO FURTHER INSTRUCTIONS WILL BE ISSUED)

To compete for a Pennsylvania State Council Knights of Columbus Scholarship, you **MUST**:

1. Complete the application on the following pages and send it no later than ***December 31, 2024***, to:

2. If you already have not done so, register and take the Scholastic Aptitude Test (SAT) of the College Board or the American College Testing (ACT) Program will be accepted. To register you must obtain the ACT or SAT Bulletin of Information and test application from your school counselor. Tests will be given on the following dates this fall:

ACT – ...July 13, 2024 ... October 26, 2024... December, 14, 2024

SAT – October 5, 2024 ...November 2, 2024 ... December 7, 2024

Classic Learning Testing Scores will also be accepted.

IMPORTANT --- ACT or SAT scores from dates later than December 31, 2024, will not be accepted.

NOTE --- Be sure to list the “Pennsylvania Knights of Columbus Scholarship Program” on the appropriate line of your test application as one of the “colleges” to receive your test score.

Our ‘school code number’ for the American College Testing Program is **ACT 3667**.

Our ‘school code number’ for the College Entrance Examination Board is **SAT 0167**.

You will not be eligible unless we receive the scores. Test scores from earlier dates are acceptable, but the applicant is responsible for our receiving such scores by ***December 31, 2024***. The results of the ACT or SAT tests will be used by the Scholarship Committee to select the group of finalists in each district. If you are selected as a finalist, you will be notified by mail and will receive three forms: 1) a Biographical Report, 2) an Essay question, and 3) a Secondary School Report. You must return these forms by the date indicated in the letter for final consideration.

SELECTION OF WINNERS

Selection of the winning applicants in each diocese will be made by a panel of three judges nominated by the State Scholarship Chairman, one of whom shall be a Catholic priest.

METHOD OF PAYMENT OF SCHOLARSHIP

The \$4,000 award to the winning candidates will be paid directly to the school they attend for tuition, room and board, books, and fees as follows: \$1000.00 per academic year, renewable each fall with evidence of satisfactory advancement. The student is required to send a copy of the billing statement to the Chairman each Fall. The scholarship is not transferable to another individual.

DEADLINE DATE TO APPLY

Your application must be postmarked by ***December 31, 2024***. Any application postmarked after that date will be ineligible for consideration.
